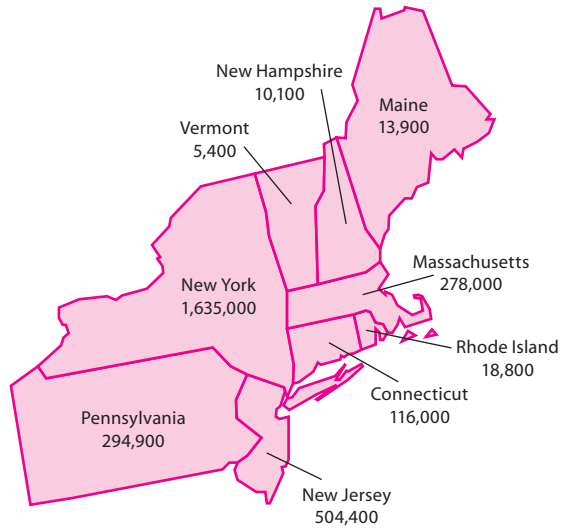


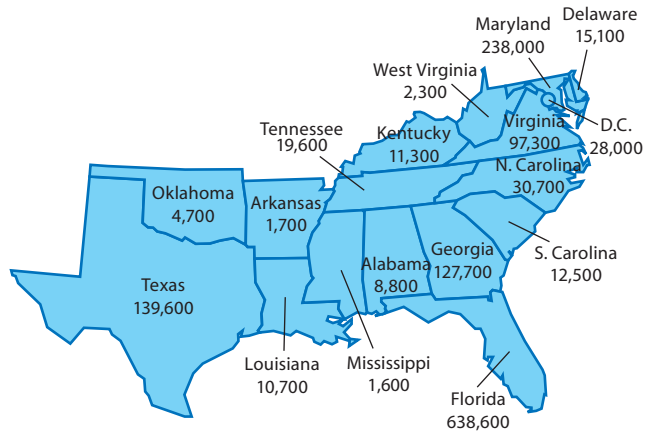
## Northeastern States\*

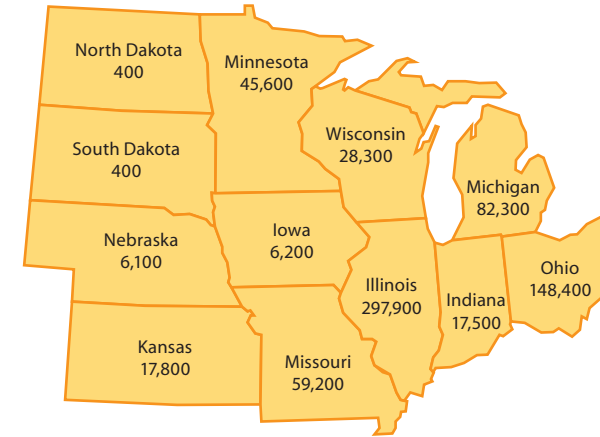

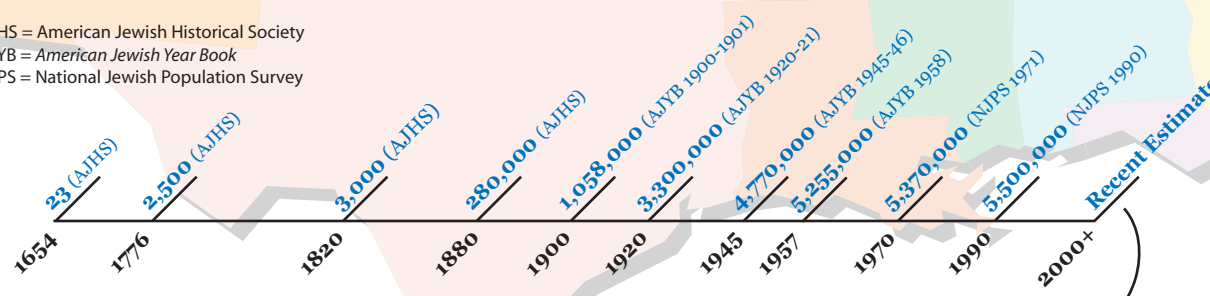
